- A resumé.
- Contact information for two professional references.
- Official college transcripts showing a cumulative GPA of no less than 3.0; a GPA below 3.0 requires completion of the GRE.

## MASTER OF ARTS AND OHIO PRESCHOOL TO GRADE 5 LICENSE

In addition to earning an initial teaching license, Master's degree, and the skills and knowledge to work with students in Preschool to Grade 5, graduates of this program will also develop skills to work with colleagues, families, and community agencies. Students can earn a second license in Special Education (K-12) as little as four additional credit hours. The program is offered through two pathways: Full Time Accelerated and Part Time Flexible. The program (via either pathway) includes a combination of asynchronous (on your own time) and synchronous online Zoom classes offered in the evenings and on Saturday mornings. A rich array of field experience brings the formal learning to life in special education settings and classrooms with mentors at the top of their practice. Additionally, this program and its pathways include course work from the Mount's internationally acclaimed Reading Science Program which is one of only 18 universities in the country rated at the A+ level by the National Council of Teacher Quality.

### Pathway 1: Accelerated 15-month full-time Master of Arts degree

- Complete the Ohio Preschool to Grade 5 licensure requirements in 12 months.
- Master of Arts degree, Major in Teaching completed in 3 additional months.
- Pathway begins in early May of each year.
- During the academic year, students are embedded in practicums and student teaching experiences and are enrolled in accelerated courses.
- As the academic year ends, students start to complete their master's degree coursework.

### Pathway 2: Part-time Flexible Master of Arts degree

- Complete the Ohio Preschool to Grade 5 licensure requirements and Master of Arts degree, Major in Teaching through a part-time flexible commitment in anywhere from 18 months to five years, depending on pace.
- Students can start the program at any point during the year.
- Throughout the program, students gain practical experience through 100 hours of practicum experiences and 15 weeks of full-time student teaching in their final semester of licensure coursework.

The recommended application deadline for the full-time program is April 1st.

This program and its pathways are approved by the Ohio Department of Education.

Program completers will have options for adding an Ohio Reading Endorsement, Ohio Pre-K Special Needs Endorsement, Ohio Teacher Leader Endorsement, and/or Ohio Gifted Intervention Specialist Endorsement.
