Mount St. Joseph University conducts a comprehensive and individualized review of each candidate's credentials, including:

- A completed graduate application. Apply online at www.msj.edu/apply.
- An undergraduate degree from a regionally accredited university. Submit official transcripts to the Office of Graduate Admission.
- A resumé.
- Contact information (name, email, and phone number) for two references who can speak to your character and abilities.
- A one-page statement introducing yourself and describing how the MBA fits into your personal and professional goals.
- An interview with the program director.

The GMAT is not required when applying to the Mount's MBA Program.
